Education Report

Questions and answers from Dr. George Mannon, Torrance Superintendent:

1. *What's new on the Torrance Schools budget scene lately? Are you still in a wait-and see mode--or will any new hires be made?* We are currently working on a best case scenario budget, which would be the Governor's proposal and an assumption that the voters will approve the extension of the taxes and fees. We will still be required to make some personnel reductions because the stimulus funds have been exhausted. Also, we are developing a worst case budget scenario in case the voters do not approve the extension of taxes and fees. This would require additional reductions, which would be extensive.
2. *What's happening on the school rehabilitation scene? Is Hull proceeding on schedule?* Hull is right on schedule to open in September 2011.
3. *Does the district have any special plans for the Torrance Centennial Year starting in September?* Laurie Love, the Committee Chair, will be at our February 7th Board Meeting to discuss plans.
4. *What do you think of the governor's budget--and what it portends?* I would give the same answer as #1.
5. *Anything else new?* All of our construction projects are moving. Phase I at Walteria has been completed and teachers moved back into their modernized class rooms last week. Phase I at South (west campus) will be completed by March 1, with teachers being able to move back into class rooms in four wings.

Actually Hull, the first new school in Torrance, was, in 1970, the last of 42 "new" TUSD campuses. Its buildings were mostly revamped "temporary" portable buildings moved from Madison Elementary School (1960-76) in North Torrance, which was closed, due to declining enrollment, and its property sold.

The school was named for Dr. J. H. Hull, first superintendent of the new Torrance School District from 1947 to 1970. He presided over building 42 new schools during that period (including remodeling the four then existing schools--Torrance High, Fern, Walteria, Torrance Elementary, and Perry.

This new Hull school cost \$22 million. The first buildings cost \$555,000; the land, \$657,000.

The 42 new schools were built in 1947-70, with about \$38 million in bond funds authorized by voters. Inflation has risen greatly over the years.

When first built, the estimated life of the new schools was about 50 years--and it was estimated that the population of Torrance might be 50,000 someday.

LWVUS

President Elisabeth MacNamara, LWVUS wrote recently:

Until the ugliness of the 2010 Election, we in the League never challenged the assumption that our reputation for nonpartisanship and competence in such core areas as voter service would allow us to pursue business as usual in an election cycle. Much of what we are experiencing highlights the need for more basic skill building, board training and community outreach. While we are addressing this need through the Membership Recruitment Initiative, webinars and convention workshops, we are reaching a self-selected audience.

With the approach of the 2012 Election, the national Board believes that we need a wider and more intentional initiative to muster our resources, hone our message and focus on our work in order to more effectively implement our core competencies across the 50 states. If the League is known for our work on elections, then a concerted effort, at all three levels, to help each other develop or hone the skills that underpin our brand and reputation is certainly in order. From debates to advocating on campaign finance reform, from fighting unjust ID requirements to registering new voters, elections are for what we are known.

Jail Study – Part 1 by Lola Ungar

On January 15, 2011, the first General Meeting on the County Jail Study was held at the home of Mary Lou Busch. The committee included Mary Lou Busch, Emma Simmons and Lola Ungar.

Lola reviewed the Los Angeles County Jail system and the Sheriff's role. The sheriff's 2009-2010 budget is \$2.5 billion, a small portion of the county budget (10% of the total expenditures). She also reviewed the various organizations involved in managing and overseeing the system.

Lola distributed a chart that she had prepared comparing the jail population and expenses in Los Angeles County, New York City and Cook County, Illinois (Chicago area).

Mary Lou informed us of the situation on overcrowding and recidivism rates. She pointed out that overcrowding causes stress, especially for the mentally ill. The solutions suggested are early release, education and vocational programs in the jails, as well as other programs.

Emma explained the mental health situation and how the inmates are processed. Many with drug problems are also mentally ill. Health care services, including mental health, for men are currently substandard. Women fare slightly better. She explained various solutions to the problem.

We did not address all of the consensus questions at this meeting and acknowledged that some concepts were unrealistic due to budget constraints. Among some of our consensus answers were:

We opposed building more jails, but accepted the concept of continuing to sentence low-risk offenders to well-monitored rehab programs outside the public jail system. We also felt that the League should advocate revision of the "three strikes law." We felt it was mandatory in many instances that basic and emergency medical care be provided inmates and that diagnostic procedures and telemedicine programs are desirable. We agreed that medical services for the mentally ill and/or drug addicts should be included. And, finally, we determined that inmates

should be released during daylight hours and not at night unless there are special circumstances.

At our next meeting on April 9 at 3 p.m. at the home of Lola Ungar, we will talk about oversight of the County Jail System, voluntary academic and/or vocational education, social rehab programs, and specified standards of the Jail System.

Redistricting

Redistricting is all about population and the one person-one vote principle. The 14th Amendment to the U.S. Constitution (the Equal Protection Clause) requires that electoral districts afford their residents equality of representation following the census required by the Constitution to take place every 10 years. The lines are drawn to provide that each district contains the same number of people.

The League of Women Voters spent over five years pursuing the concept of an Independent Redistricting Commission and achieved that with the 2009 election. The legislature drew

their own lines and gerrymandered odd-shaped districts throughout the state for the Assembly, the Senate, the State Board of Equalization, and California Representatives to the Federal House of Representatives every 10 years once the population census was conducted.



Now, that task will be conducted by a new fourteen member Independent State Redistricting Commission which will be meeting all around the state and preparing to redraw the lines which are due in reports and maps by Sept. 11, 2011. When adjusting county supervisorial district boundaries, the California Elections Code also requires that, "districts shall be as nearly equal in population as may be." That is why the Los Angeles County Board of Supervisors has appointed ten voting members and ten alternate members (two voting and two alternates by each Supervisor) to meet in the next few months with the aid of staff to secure consultant assistance, and design a website. The U.S. census data is due April 1, 2011 and then throughout the U.S., everyone will be making a mad dash to analyze existing election district boundaries using the new 2011 redistricting data, activate a redistricting public worksite, and the Los Angeles County Boundary Review Committee (BRC) will start deliberations. Following these deliberations



and hearings, the BRC will recommend a redistricting plan(s) to the Board of Supervisors, whereupon the Board will hold public hearings on the proposed redistricting plan during the month of August 2011. It is planned that the Board adopt the plan by Sept. 11, 2011 but no later than Oct.31, 2011.

I have taken on the task of following this process of the Supervisorial Redistricting. You can go to <http://www.healthycity.org/> to figure out and plot spheres of influence, common interests, schools, hospitals, ethnicity, age groupings, and other interesting data along

with estimated data before the actual numbers are published in April from the U.S. Census. By doing this, you can become involved and be able to speak before the Independent California Redistricting Commission, the County Board of Supervisors, or other local boards.

Balancing the State Budget

meeting, 90 participants took part in an online game called the *California Budget Challenge* at the website <http://www.next10.org/> and managed to come as close as \$2.2 billion of balancing the budget and solving California's budget crisis. Sure, we did away with some subsidies and raised some taxes but that's the best way to solve the dilemma. We advise you to go to that website and see what you can do. A gentleman from Redondo Beach wrote to the Breeze and said that the voters couldn't do it but we say the voters can and then they can advise their legislative representatives on the best approach.

Privatization

Finally, save the date for the 49th LWV/LA County Convention with a theme related to Privatization (and related to the LWVUS Study) that will take place on March 26 from 9 a.m. to 12 noon at Recreation Park Golf Course in Long Beach. Our League can have three delegates for this convention and all members are encouraged to attend. You shall hear more later on the speaker and breakfast details.
